**In the matter of:-** Appeal against the Order dated 19-05-1992 passed on Mutation No 1381 under Section 8 of Agrarian Reforms Act 1976 of Village Gadi Garh, Tehsil Jammu now Tehsil Gadigarh, District Jammu where under the absolute ownership rights in respect of land falling under Survey No. 1632 measuring 1 kanal 10 marlas situated in Village Gadigarh, Tehsil Jammu has wrongly and illegally conferred in favour of Respondent Brij Lal S/o Chandu Ram against the mandate of Law.

## ORDER

1. Counsel for appellants has filed these appeals against order dated 27-09-1989 passed on mutation No. 1131 attested under section 4 of Agrarian Reforms Act, 1976 and order dated 19-05-1992 passed on mutation No. 1381 attested under section 8 of Agrarian Reforms Act, 1976 of Village Gadi Garh, Tehsil Jammu South (now), District Jammu on the ground that the subject land was allotted to his father under Government Order No. 578/C of 1954 and ownership rights are conferred upon under Cabinet Order 254/C.
2. At this state, counsel for appellants requested to transfer this matter to Additional Deputy Commissioner, Jammu for further disposal under Law. Since Additional Deputy Commissioner (Law and Order), Jammu hold concurrent powers of this court, as such, his prayer is accepted and these matters are transferred to Additional Deputy Commissioner (Law and

Order), Jammu for further disposal under law. Parties are directed to appear before the Court of Additional Deputy Commissioner (Law and Order), Jammu on 25.05.2022.
