The above arrangement shall, however, be without prejudice to the outcome of writ petition (s), if any, pending before the Hon'ble Court(s) and shall not confer any preferential right on any of the GQs as the seniority list for their substantive promotion as Naib Tehsildars as and when made.

The concerned officials shall be required to submit before the concerned Tehsildars/DDOs, an affidavit duly attested by the Judicial Magistrate stating therein that they will not claim any right for out of turn promotion or any monetary benefit.

The officials are required to join their new place of assignment within 03 days from the date of issuance of this order and all such Girdawars who fail to join within prescribed time, shall be deemed to be working at their previous place of postings as Girdawars and the next eligible Girdawars strictly as per seniority shall be placed against their places to make these vacant Niabats / posts functional.
