- (a) The appointee shall furnish an undertaking in the shape of an affidavit to the effect that if, on verification, genuineness of the qualification from the concerned issuing authority are found fake/forged, the appointment shall be treated to have been cancelled *ab-initio* and the legal action as warranted under rules shall be initiated against him.
- (b) The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of genuineness of Qualification/Date of Birth is received from the concerned authorities.
