Subject:- Initiation of Regular Departmental Action against Sh. Ajay Kumar the then Jr. Assistant, in the office of Sub Divisional Magistrate, Ghagwal - Appointment of Inquiry Officer in terms of Rule 33 of J&K Civil Services (Classification, Control & Appeal) Rules, 1956, thereof.

Whereas: Divisional Commissioner, Jammu vide letter No. 503/71200004/RDA/758-59 dated 03.03.2023, has requested and endorsed the request of Deputy Commissioner Samba, for initiation of Regular Departmental Action against Sh. Ajay Kumar, the then Jr. Assistant, in the office of Sub Divisional Magistrate Ghagwal, for commission of offences of embezzlement and deliberate retention of huge sums of Government money received on account of registration fees in his personal possession for long time with malafide intentions and failing to deposit the same with the Government treasury; and

Whereas; the report of the preliminary inquiry committee constituted by the Deputy Commissioner, Samba has enquired the charges against the delinquent official and has established the charges thereupon after providing due opportunity of heard to the accused and the same has been examined and the Competent Authority has decided to conduct an exhaustive enquiry into the allegations leveled against the delinquent official.

Now therefore, in terms of Rule 33(4) of J&K Civil Services (Classification, Control and Appeal) Rules, 1956, sanction is hereby accorded for initiation of Regular Departmental Action against Sh. Ajay Kumar, the then Junior Assistant in the office of Sub Divisional Magistrate, Ghagwal.

Sh. Suresh Chander (JKAS), Additional Deputy Commissioner, Samba, is appointed as Inquiry Officer, to enquire into the charges framed against Sh. Ajay Kumar, the then Junior Assistant, in the office of Sub Divisional Magistrate Ghagwal (presently under suspension) and Sh. Rajesh Kumar (JKAS), Sub Divisional Magistrate, Vijaypur, shall be the Presenting Officer.

Further, the Inquiry Officer shall conduct an in-depth/exhaustive enquiry and submit his findings/report along with specific report/recommendations within 21 days of issuance of this order.
