This is an appeal preferred under section 7 of the Jammu and Kashmir Migrant Immovable Property (Preservation, Protection and Restraint on Distress Sales) Act, 1997 whereunder the orders dated 08.03.2021 and 18.03.2021 passed by Divisional Commissioner Kashmir and Tehsildar (South) Srinagar respectively have been called in auestion.

- 2. The appellant Counsel did not cause his presence from the date of presentation of Appeal except on one date of hearing.
